





1.4.1 After selecting the Edit, a new window will open containing the details of Energy Injection data submitted by RE Generator.

- The RLDC can edit the data in column A B, C and E. The value in column D, F and F1 will automatically update.
- If value in F1 gets reduced, then in “G. RECs requested” will update corresponding to value in F1.
- If value in F1 gets increased, then in “G. RECs requested” will remain same as requested by RE Generator.

Now hit the submit button to save the updated details. After submitting the data, a message will appear that data submitted successfully.

2.4.1 After **selecting** the **Edit**, a new window will open containing the **details** of **Energy Injection data submitted by RE Generator**.

- RLDC can edit the data in column A, B, C and D. Based on the values of B & D, data in B1 & D1 will automatically update.
- If value in B1 gets reduced, then in “*E. RECs requested for Energy used for Self-Consumption (Non-Tradeable RECs)*” will update corresponding to value in B1.
- If value in B1 gets increased, then in “*E. RECs requested for Energy used for Self-Consumption (Non-Tradeable RECs)*” will remain same as requested by RE Generator.
- If value in D1 gets reduced, then in “*F. RECs requested for Energy Injected in the Grid (Tradeable RECs)*” will update corresponding to value in D1.
- If value in D1 gets increased, then in “*F. RECs requested for Energy Injected in the Grid (Tradeable RECs)*” will remain same as requested by RE Generator.

#### 4. Timelines to be followed: -

4.1 The eligible entity shall submit the application to RLDC/RLDC for issuance of Energy Injection Report within three months of electricity generated and injected into the grid or deemed to be injected in case of self-consumption by the CGP based on renewable energy sources.

4.2 RLDC/ RLDC shall issue the Energy Injection Report of eligible entity within one month of receipt of application from eligible entity.

4.3 Application for issuance of Certificates shall be made by an eligible entity to the Central Agency within six months from the corresponding generation by the eligible entity. Provided that no Certificate shall be issued if the application is made beyond the period of six months from the corresponding generation. In the case of revision of REA or DSM the difference in energy can be adjusted in subsequent EIRs and accordingly the number of RECs will be issued.
